Have you ever heard a racial joke at work or received a dirty email from a coworker? You are not alone! EEOC claims of discrimination, harassment, and retaliation have soared to record high levels in the past two years - up more than 10%. It is now more critical than ever that companies train supervisors, managers, and human resource professionals on these topics. Training helps prevent claims and minimize legal exposure should a claim be filed.

In this small-group workshop, attendees will learn practical strategies that will help them manage in ways that minimize liability and promote respectful workplaces. Experienced Council staff will lead attendees through a thought-provoking discussion, providing real-world examples and no-nonsense answers to the following questions:

- ▶ What are discrimination, harassment, and retaliation?
- ▶ How do such behaviors impact the workplace?
- ▶ When is an employer liable?
- ▶ How can you personally avoid these illegal behaviors?
- ▶ What are your additional, preventative management responsibilities?
- ▶ What should you do if you receive an employee complaint?
